Automatic Bank Draft Service (Tennis Membership)

This form is for activating a monthly automatic bank draft for payment of your tennis membership at the City of Auburn Yarbrough Tennis Center (COAYTC). Please fill out the form; include a voided check for the account from which you wish to have the bill drafted. At the time of the contract, we will collect two months premium. We will test the auto draft to insure all of the account and routing numbers are correct. During this start-up period, your account will not be drafted. Monthly membership premiums will be automatically withdrawn from your bank account on the first of each month. This membership plan can be canceled after one year at any time by sending a written request by the 15<sup>th</sup> of the month to COA YTC and cancellation becomes effective on the last day of the month. Unless such a cancellation notice is sent by the 15<sup>th</sup> of the month, the contract between the City of Auburn and member are automatically renewed for another month. Membership fees are not refundable or transferable in whole or in part. **By signing this contract, you are agreeing to pay the membership for one year. If for any reason you change accounts or top payment on your monthly membership, you will have to pay the remainder of the membership before you will be allowed to use the courts.
